Mentor Application Form

Applications must be postmarked June 21, 2010 for consideration!

Application to the RMASFAA Leadership Pipeline is open to individuals from RMAFSAA member institutions. Mentors will be selected by the Leadership Pipeline Committee based on the applicant's own merits as presented in the application and supporting documents. The Committee seeks representation from a cross-section of the Association with diversity and balance in areas such as occupation/position, institution type and individual attributes. The Leadership Pipeline Committee looks for:

- Evidence of previous leadership role in state or RMASFAA associations.
- Individuals who will add to the mentoring program and association's leadership through diversity of experience and perspective.
- Commitment to mentoring and bringing forward new leaders.
- Commitment & motivation for service in state and RMASFAA associations.
- Ability to make the time commitment.

Applicants must have the full support of their direct supervisor and employer/institution. Individuals may nominate themselves, but must provide evidence that the employer will allow time for participation, including monthly meetings (via teleconferencing, etc.) and attendance at the RMASFAA Fall Conference.

Mentors and assigned mentees are required to attend the Leadership Pipeline Seminar, which is the official initiation of participation in the program. Mentors and mentees attend the Leadership Pipeline Seminar held in conjunction with the RMASFAA Fall Conference. Attendance is expected for all monthly meetings. Mentors are critical to the success of this program and must make the commitment that no monthly meetings or activities will be missed. If unforeseen circumstances cause the mentor to miss a meeting, the mentor is responsible for working with the Leadership Pipeline Committee to insure the mentee receives mentoring on the topic for the month.

Class size will be limited to 20 mentoring pairs. Selection of mentors will be based on criteria specified on the application form. **Submitted Applications must be postmarked by June 21, 2010.** Notification will be made by July 14, 2010. Applicants are required to submit a letter of recommendation from his/her direct supervisor.
